Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. What happens when I limit sharing for an account I hold jointly with someone else?	<ul> <li>If you limit sharing with affiliates, your choices will apply individually unless you tell us otherwise.
